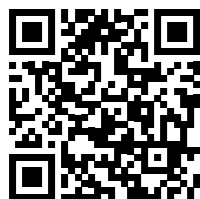

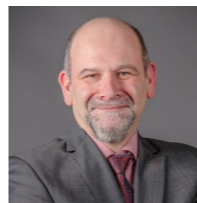

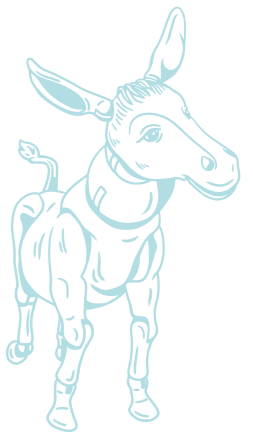

DIEKIRCH'S PUBLIC DEBT GENERAL OVERVIEW 2012-2023

A long-term, assertive, responsible, and future-oriented financial policy by the LSAP majority in the municipal council.

During 2012-2023, **NOT A SINGLE LOAN** was taken out under the LSAP majority.

This continuous debt repayment is the prerequisite allowing to effortlessly meet the financial challenges of the next term.

In 2016, 16 bonds were combined into 2 (maturity of 17 and 10 years respectively) to benefit from a more favourable fixed interest rate on the financial market.

The municipality can continue to build upon a **stable and healthy financial situation**.

The **far-sighted and responsible financial policy** under the LSAP majority not only consisted of the debt reduction mentioned above but also and above all, in an active investment policy.

During the last term, between 2018 and 2023, **over 400! projects have been presented** in our city's extraordinary budget.

Some examples of projects financed without taking up a loan:

- **Cinema complex with 5 screens** (execution of the purchase option and payment over 5 years from 2018-2022).
- Purchase of the area behind the new "Maison Relais" for the **development of a "nature playground"** for the "Maison Relais".
- **Real estate purchases** in "rue Clairefontaine", "rue St. Antoine", and "route de Gilsdorf" to create **social housing units** and in "rue Alexis Heck" to **develop the municipal archive and library**.
- **Complete renovation of road infrastructures** in the following streets: "rue du Pont", "rue de la Croix", "Cité Klein", "rue du Palais", "rue du Pensionnat", "rue du Tilleul".
- Complete renovation of the **"Stade municipal"**.
- Renovation of the **"Maison de l'Orientation"**.
- Renovation of the **"Musée Nationale d'Histoire Militaire"**.



Further planned investments for the term between 2024 and 2029.

The LSAP stays committed to **responsibly and carefully managing public funds**. However, LSAP Diekirch understands the upcoming investments, such as:

- **New "Maison Relais"**, definitive purchase by execution of the contractual purchase option,
- **Municipal archive and library** in the Villa Conter,
- New construction of the **"Conservatoire de Musique du Nord - Site Diekirch"**,
- **Multi-storey car park "Gare"**,
- **Day-care "Maison Origer"**,
- **Conversion of the municipality's own heating power plant to renewable energy,**

must be financed **in part by taking out loans**.

This should not be dramatized, because **those investments are necessary** to continue with projects that are benefitting the future generations in our city. Financing these projects is **not a debt, but an investment into our children's future**.

Our financial policy during the last two terms leaves enough margin to continue our policy for **the benefit of the citizens of Diekirch**.

The LSAP majority is proud to be able to present the city with healthy finances and a very high quality of life after 12 years of political progress.

DID YOU KNOW...

Regarding the purchase of land and development of the new "Conservatoire de Musique du Nord - Site Diekirch" in the "rue de l'Hôpital":

NO: The current LSAP majority has absolutely nothing to hide or conceal regarding this decision.

NO: The building permit for the planned retirement home was not overruled by the court based on a constructional issue, but solely on the argument that no private individual has a right to own a housing unit in a "BEP zone" ("Bâtiments et équipements publics"). With its decision to dismiss the project, the "Tribunal Administratif" harmed the people who invested in their future retirement by purchasing a unit.

NO: The municipality has NOT acquired the building plans of the retirement home.

NO: It is not possible to further extend the current site of the "Conservatoire de Musique du Nord - Site Diekirch" at "Wirtgen Castle" due to the reclassification of the building as a national monument at the request of the CSV-Diekirch.

Yes: This project is a **substantial financial investment**.

Yes: It is a **pedagogically valuable project**.

Yes: It is the ideal location, **neighbouring the new "Maison Relais" and the primary school**.

Yes: It is a **great opportunity to offer our primary school-aged children the diverse programme of the Music Conservatoire**.

Yes: Together with the "Maison Relais", the primary school and the "Maison de Soins Sacré Coeur", **intergenerational projects** can and should be offered here.

Yes: The municipality has acquired the **land with the tender-ready plans for constructing** the "Conservatoire de Musique du Nord - Site Diekirch".

Yes: The plans were drawn up based on the **"cahier de charges" established by the "Conservatoire de Musique du Nord" management**.

Yes: The plans have been presented to the Ministry of Education - Division of Music Education.

Yes: The Ministry has confirmed in writing that **this project is eligible for a 30% subsidy**.

Yes: With the conclusion of the notarial deed, **all expenses** (architect's fees and settlements of all planning offices) **incurred up to the public tender, i.e. for the detailed elaboration of this project, are paid off**.

Yes: The **final purchase** of the land, including the project for the construction of the new "Conservatoire de Musique du Nord - Site Diekirch", was **approved by the Municipal Council at its meeting on the 22nd May 2023, with the votes of the LSAP majority**.

The LSAP stands by this project.
